### President's Message

This change will provide the flexibility necessary to recruit a Commissioner with the necessary managerial skills to do the job."



"Over the past five years, the Bloomberg Administration has worked to overhaul the Buildings Department. Last year, the Mayor and the Council enacted a comprehensive overhaul of the City's Building Code and announced a three-phase "Special Enforcement Plan" to make construction sites safer."

Despite all of this effort, expediters are still free to offer professional services illegally and contractors still do not need to know how to read plans. Architects and engineers are receiving ECB fines for failing to sign a Directive 14 Final Inspection, but there is no prescribed alternative if it can't be signed off.

Rule 101-06 Special Inspectors and Special Inspection charge.

Rule 101-07 Approved Agencies introduces the four types of agencies that test and inspect material, equipment and construction relate activity. These agencies are Approved Testing Agencies, Concrete Testing Laboratories, Approved Inspection Agencies and Approved Progress Inspection Agencies. It requires these agencies to have a licensed design professional as its full time director. It also requires these agencies to be formed and structured in compliance with the NYS Education Law. The only purpose of any of these agencies is to provide signed and sealed documents by a licensed design professional, therefore, they must be professional organizations as per the Education Law requirements.

Rule 101-10 Final Inspection and Sign Off codifies the Building Departments desire to have the final inspection performed within 12 months of the expiration of the last valid permit. The inspection report shall be filed within 30 days of that inspection to attest that the work is substantially compliant with the approved construction documents. Unfortunately, it does not allow for jobs that are incomplete or incorrect. It also requires the inspector to track the permits.

Members of our chapter testified at all three hearings that were held on this past Friday and Monday. Our State President, Robert Stelianou PE also testified by letter at these hearings. The prepared testimony that was presented will be available on the web site.

#### INTRODUCTION BILL 755

Despite the trouncing that this bill received from both the public and every city council person who spoke at the Public Hearing on May 7th, the Mayor and **Speaker Quinn** are still committed to move forward with the Administration's proposal to change the qualifications for the Buildings Commissioner to require that either the Buildings Commissioner or the First Deputy Commissioner be a registered architect or licensed engineer. The Mayor states that this change will provide the flexibility necessary to recruit a Commissioner with the necessary managerial skills to do the job. There are rumors afloat that this bill may be pushed into the full council for a vote. Please contact every Council person that you can, especially those from your neighborhood to let them know what a disastrous idea this is.

#### THE NEW CONSTRUCTION CODE

For those who have been overseas for the past several years, July 1st is the day that the earth, or at least the Building Department will stand still as the new Construction Code goes into effect. Over the past week, there have been two and a half hour waits just to get a ticket in the Building Department. On Friday, June 27th, the Building Department will not accept any new filings. On Monday, June 30th, only the new forms can be used to file jobs. Yes there are new forms, lots and lots of new forms, some of which aren't even available yet.

#### Engineer Is Charged in Fatal Wall Collapse

As reported by Sewell Chan in the NY Times, a licensed engineer has been charged with filing fraudulent plans with the Department of Buildings in connection with a Brooklyn construction site where a day laborer died in March when earth and debris collapsed on him. The engineer, Abraham Hertzberg, 86, of Kings Point, on Long Island, faces nine first-degree counts of offering a false instrument for filing in the first degree, a felony. If convicted, he could face up to three years in prison on each count. According to the indictment, Mr. Hertzberg had previously lost his authority to self-certify architectural designs and used a stamp belonging to his partner, Louis Sanchez, to certify them in Mr. Sanchez's name. He also placed Mr. Sanchez's signature on several documents filed in support of the client's applications for building permits, according to the Brooklyn district attorney, Charles J. Hynes.
